Appeals Policy for the Ethics Committee

Guidelines for Handling Appeals from the Ethics Review Committee to the Ethics Integrity Committee

Introduction

This document outlines the appeals policy for the Ethics Committee, detailing the procedures for escalating appeals from the Ethics Review Committee to the Ethics Integrity Committee. The policy aims to ensure fairness, transparency, and accountability in the decision-making process concerning ethical matters.

Purpose

Definitions

Ethics Review Committee

Ethics Integrity Committee

The Ethics Integrity Committee is responsible for handling appeals against decisions made by the Ethics Review Committee. It ensures that the appeals process is conducted fairly and that all relevant information is considered.

Scope

Appeals Process

Filing an Appeal

- 1. Any individual or entity wishing to appeal a decision made by the Ethics Review Committee must submit a written appeal to the Ethics Integrity Committee within 30 days of the decision.
- 2. The written appeal must include:
 - A detailed description of the decision being appealed
 - Specific grounds for the appeal
 - Any supporting documentation or evidence

Review of Appeal

- 1. Upon receipt of the written appeal, the Ethics Integrity Committee will acknowledge the appeal within 7 days.
- 2. The Ethics Integrity Committee will conduct a thorough review of the appeal, considering all relevant information and documentation.
- 3. The review process may include:
 - Interviews with relevant parties
 - Review of additional evidence
 - Consultation with experts or advisors

Decision on Appeal

- 1. The Ethics Integrity Committee will make a determination on the appeal within 45 days of receipt.
- 2. The decision will be communicated in writing to the appellant and the Ethics Review Committee.
- 3. The decision of the Ethics Integrity Committee is final and binding.

Confidentiality

- 1. All information related to appeals will be treated with the utmost confidentiality.
- 2. Only individuals directly involved in the appeals process will have access to confidential information.

3. Any breaches of confidentiality will be subject to disciplinary action.

Record Keeping

1. The Ethics Integrity Committee will maintain complete records of all appeals,

including:

Written appeals

Supporting documentation

Decisions and outcomes

2. Records will be retained for a minimum of 5 years from the date of the final decision.

Training and Awareness

1. All members of the Ethics Review Committee and the Ethics Integrity Committee will

receive training on the appeals policy and procedures.

2. Periodic updates and refresher courses will be provided to ensure continued

compliance and awareness.

Review and Amendments

1. This appeals policy will be reviewed annually to ensure its continued relevance and

effectiveness.

2. Any amendments to the policy will be communicated to all relevant parties in a timely

manner.
